

## Notes to the Director's Estimated Statement of Affairs as at the 29 August 2014

### 1 Leased Assets

The Company had a tracked excavator on a lease purchase contract from Hyundai Construction Finance Ltd. The excavator has been returned to the finance company.

### 2 Fixed Asset Investments

The Company's fixed asset investments have been valued by the Director at £1.

### 3 Debtors

The Company has book debts at 29 August 2014 of £65,543. The director has estimated that after provisions these debts will realise £13,294.

### 4 Associated Company

There is an outstanding debt from an associated Company, Fry Demolition Limited, with an estimated balance of £148,288. However, due to the financial position of this Company, the director estimates the amount recoverable to be uncertain.

### 5. Nat West Bank

The Company operated a current account with Nat West Bank Plc and the estimated balance on the current account is £62,378. The Company also has a Bank deposit account with the Bank of £1 which gives net cash at bank of £62,379. The Bank is secured by a fixed and floating debenture created 6 October 2000 and is registered on 17 October 2000.

### 6 Preferential Creditors

The amount is estimated at £20,567 and is due to the fact that twenty former employees have been made redundant and are awaiting payments for wages and any unpaid holiday pay.

### 7 Trade and Expense Creditors

The amounts shown as due to the unsecured creditors have been extracted from the Company's books and records. The agreement of the individual creditor claims is a matter for the Administrator to adjudicate.

### 8 HMRC – PAYE

The PAYE liability outstanding relates to the final six months of trading and is estimated at £60,983 net of CIS adjustments.

9 **HMRC – VAT**

The VAT liability relates to the last quarter and final period of trading and is estimated at £101,851

10 **Redundancy and Pay in Lieu**

The Company employed twenty people, all of whom were made redundant on 8 August 2014  
This is an estimate of their entitlement for redundancy and pay in lieu of notice

11 **Excess Wages Claims**

This represents the amount due in respect of unpaid wages in excess of the preferential limit

12 **Director's Loan Account**

This is an estimate of the amounts due to the Estate of Mr G Fry

13 **Finance Lease Shortfall**

This represents an estimate of the balance due to the finance companies after the disposal or return of the assets

14 **Inter Company Accounts**

This is an estimate of the amount owed to G Fry Plant Hire Limited as follows -
