



### **Notes to the Directors Statement of Affairs**

**Dated: 2 May 2014**

#### **Valuations**

Plant and machinery, furniture and stock have been valued by independent valuers, H & H James Sutherland of Newcastle upon Tyne

The freehold properties were independently valued on behalf of the chargeholder in 2011 by Browns Chartered Surveyors Property Consultants a member of the Royal Institution of Chartered Surveyors

#### **Properties**

The Company own the building in which they trade from at Studio House, 3 Hunter House Industrial Estate, Tofts Farm, Hartlepool, TS25 2BE and a residential property at 5 Chadburn Road, Norton, Stockton on Tees, TS20 2DQ which they currently rent to a tenant

Both properties are subject to a legal charge with Lloyds Bank

#### **Plant and Machinery**

Plant & Machinery with a net book value of £2,958, is estimated to realise £nil on a forced sale basis

#### **Office Furniture/stock**

Office furniture and stock with a net book value of £962, is estimated to realise £150 on a forced sale basis

#### **Cash in hand /petty cash**

The Company has deposited £8,400 to partially cover the costs and expenses of the Liquidation which may not be recoverable by Tait Walker

An amount of £20 79 remained in the company's petty cash

#### **Book Debts**

The Company held a fixed & floating debenture with Hitachi Capital (UK) Plc Hitachi statements indicate gross book debts of £5,201 40

The director estimates that after provisions for bad and doubtful debts, and counterclaims following the cessation of trade, that the book debts will realise £3,000

Hitachi are owed in the region of £557 32 not including termination charges

## **Employees**

Employees of the Company have claims for arrears of pay, holiday pay, pay in lieu of notice and redundancy pay, as appropriate, following the termination of their contact

Both arrears of pay and holiday pay rank as preferential claims subject to statutory limits. Amounts in excess of the statutory limits together with pay in lieu of notice and redundancy pay rank as unsecured claims.

Employee claims have been estimated based upon information available at present. Certain of the employee claims will be discharged through the National Insurance Fund, and the fund will have subrogated claims for any amounts paid to the employees.

## **Prescribed Part**

The Prescribed Part (Section 176(A) of the Act) is a proportion of floating charge asset realisations, net of costs, which are set aside for the benefit of unsecured creditors. The Prescribed Part applies to floating charges created on or after 15 September 2003 only.

The Prescribed Part is calculated using a formula laid down in the Act as follows:

- 50% of the net property up to £10,000,
- 20% of the net property in excess of £10,000;
- Subject to a maximum amount of £600,000.

We estimate, to the best of our knowledge and belief based on the information known to date, that:

- The value of the Company's net property, before any costs, is £28,180 74 and
- The value of the prescribed part of the net property will be in the region of £8,636 15

The Liquidators may seek a Court order not to distribute the Prescribed Part if they consider that the costs of making a distribution will be disproportionate to the benefits, or can automatically conclude the same without Court approval if the net property is below £10,000.

## **Trade & Expense Creditors**

The amounts due to trade and expense creditors are taken from the books and records of the Company, and are stated inclusive of VAT. Inclusion does not constitute an admission that there is now or has been in the past any legal liability upon the Company of the whole or part of the amount shown.

## **General**

The Statement of Affairs does not include any provision for the costs of administering the Liquidation.
