

**Statement Of Affairs Notes**

**Note 1**

The company loaned monies to Konsolz com Ltd, and the sum of £165,450 remains outstanding. The director of Konsolz com Ltd is also the director of this company. The Liquidator will need to pursue this debt in due course.

**Note 2**

The Director has advanced this sum in order to meet the costs of Liquidation and it is therefore included in his balance as a creditor.

**Note 3**

The Liquidator is currently holding the sum of £1,041 which represents the balance in the company's bank account as at the date of cessation.

**Note 4**

A breakdown of the HM Revenue & Customs arrears are set out below -

The director considers that there are no liabilities due to HMRC in respect of VAT and CT. However, HMRC have shown concern in respect of inaccuracies on VAT returns and have issued assessments totalling £669,853.00. The director disputes this amount and for that reason has been excluded from the statement of affairs. This disputed claim, will need to be reviewed by the Liquidator and adjudicated upon in due course.
