

### **Notes to the Statement of Affairs**

- 1 The Company's latest filed accounts show that its tangible fixed assets had a net book value of £2,843 as at 31 August 2007 and £9 as at 31 August 2008. These assets have been valued by independent agents, Robson Kay & Company Limited, with an estimated realisable value in the region of £2,000 before agents' costs.
- 2 The Company's debtors are factored with Ashley Commercial Finance Limited and they have advised that their sales ledger balance presently stand at £10,170, of which virtually all of these debts are now in aged. Ashley Commercial is presently holding approximately £760 and it is anticipated that there may be a surplus to the Liquidator in the order of £4,000 after taking into account of their charges.
- 3 Claims of creditors are subject to agreement in due course.
- 4 The Directors have advised that they each have a director's loan account with a nominal credit balance but they are unable to quantify the balance at the time of preparing this report. They have further added that they have used their personal credit cards to pay for company's essential business expenses and the amount paid by them is likely to have exceeded the credit balance on their directors' loan account.
- 5 Section 176A of the Insolvency Act 1986 required the Liquidator to set aside a prescribed amount of the company's 'net property' towards the satisfaction of unsecured debts. Net property is the amount of property that would otherwise be available for satisfaction of holders of debentures secured by, or holders of, any floating charges created by the company after 15 September 2003. In this case, there are two floating charges registered on or after this date but the prescribed part is likely to be nil, as the value of the net property is nil.
- 6 No provision has been made in respect of claims by employees under the terms of the Employment Rights Act 1996.
- 7 Subject to the costs and expenses of the winding up.
- 8 Subject to the verbal explanations to be given at the meeting of creditors 8 January 2010.
