

**Think Media Limited - Notes To The Estimated Statement Of Affairs**

- 1 The inclusion of any claim does not constitute an admittance of the debt All claims are subject to formal adjudication
- 2 The above estimates are subject to the expenses of the liquidation and the expenses of realisation
- 3 HSBC Bank has a fixed and floating charge dated 17 February 2005 over the company's assets however the account was closed in 2008
- 4 The balance currently due in respect of the overdrawn director's loan account is £35,600, although this will need to be reviewed by the liquidator(s) It is currently uncertain what repayments will be possible
- 5 The valuations are the director's estimates, and no professional valuation has been obtained
- 6 PAYE/NIC is outstanding for the years ended 5 April 2010, 2011 and 2014
- 7 Corporation Tax is outstanding for the five years ended 31 December 2013 It is anticipated that losses for the final period of trading will result in a refund of approximately £3,000 which will be set off against the remaining HMRC liability
- 8 As at 31 December 2013 the sum of £19,046 had been paid to HMRC in respect of s455 tax on the director's loan account Repayments have been made since that date and the sum of £10,146 is currently claimable based on the amount showing on the statement of affairs Further sums will become claimable as and when further repayments are made Any repayment will be set off against the remaining HMRC liability
- 9 VAT is outstanding for the period 1 November 2014 to date It is anticipated that there will be a refund of approximately £1,100 which will be set off against the remaining HMRC liability
