- 3 The company owns a property at 184/184A Hessle Road, Hull The book value is as per the company accounts dated 31 August 2014 The property is currently being marketed by Garness Jones and the estimated to realise value is as per their sale price The property is not subject to any mortgage but is subject to a charge in favour of Two Minutes to Midnight Limited who have provided funding to satisfy the debt due to RDM Factors Limited

- 4 There are a number of debts due to the company The book value is per the company records as at 28 April 2015 The estimated to realise value is uncertain
