

- 2 The above estimates are subject to the expenses of the liquidation and the expenses of realisation
- 3 A valuation of the assets has been carried out by Jordan Glen BA, MBA of Empire Auctions Limited, London WC1 3AF on the basis of a fair market value for liquidated items Goodwill has been valued after consideration of the trading name, website, customer base, period of trading and projected turnover
- 4 There are no known bad book debts All debtors are current and are expected to pay in full
- 5 PAYE/NIC /CIS tax is outstanding for the period April 2008 to date
- 6 VAT is outstanding for the period September 2012 to date
- 7 Attached to the report to creditors are accounts for the two years to 30 April 2007 and 30 April 2008 Details of the 2006 have not been included as it is considered that they provide no additional helpful information with regard to the company's current financial position
- 8 It has not been possible to establish the level of director's remuneration paid during 2007 and 2008 as only abbreviated accounts are available
- 9 A deficiency account has not been prepared as the latest accounts prepared are to 30 April 2008 A deficiency account would therefore cover a period of almost 5 years and is likely to be misleading as regards the company's losses during the period
