



### **Notes to Statement of Affairs**

- 1 The book value for the motor vehicles in the last accounts was £14,432 00 but this was not split the values in relation to the vehicles This figure has been split for the purposes of the statements of affairs by using the current value for the financed vehicle and the remainder for the unfinanced vehicle
- 2 The company owns 3 sets of personalised number plates These do not appear separately in the company accounts and so have not been attributed a book value
- 3 For the purposes of the Statement of Affairs in relation to Book Debts, the expected to realise figure has taken into account bad debts that are not expected to be paid and a provision of 40% has been made for further disputes and possible bad debts
- 4 The estimated to realise figures for Motor Vehicles, Furniture & Equipment & IT and the number plates have all been taken from a professional valuation provided by Gavel Auctioneers
