- 1 This investment consists of the share capital of a subsidiary company, Lietcorp Limited (a dormant company)
- 2 The Company is the sole member of Ocean LED USA LLC, a company incorporated in the USA. There is no authorised or issued share capital however, it is controlled by the company due to its interest as the sole member. The cost of this investment is nil although it has been estimated to realise £1
- 3 The book debt value has been taken from the management accounts prepared up to 12 March 2014. The estimated to realise value has been taken from the sale agreements with the purchasing entities namely, Ocean-LED Marine Limited and Future Energy Lighting Technology Limited
- 4 This relates to an inter-company debt with Ocean LED USA LLC ("USA"). USA has equally suffered substantial losses and has an insolvent balance sheet and therefore the realisation of this inter-company book debt would have been extremely speculative
- 5 Based on the VAT returns submitted up to the 14 March 2014, there is a VAT refund due of £78,735. This will be subject to crown set off and therefore no realisations are expected
- 6 The Company's employees were transferred to Ocean-LED Marine Limited and Future Energy Lighting Technology Limited under the Transfer of Undertakings (Protection of Employment) legislation ("TUPE"). As a result of TUPE, there will be no preferential or unsecured claims from the employees
