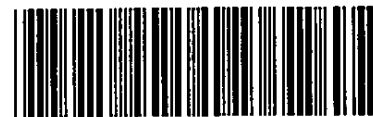



1 Book Debts

The book debts consist of 4 debtors with a book value of £21,563. It is estimated that £2,527 will be realisable, as two of the larger debtors are also creditors of the company and it is therefore likely that their claims will be offset.

2 Office Equipment

Cash at bank of £200 is estimated to be recovered.

3 Trade & Expense Creditors

A schedule of the Company's creditors is attached at Appendix B.

4 Directors

The directors are creditors for the sum of £562,400 for personal funds loaned to the company.
