





- 3 In August 2012 HMRC issued a claim in the Northampton County Court for alleged non-payment of National Insurance contributions, which with interest and legal costs amounted to £258,018.42. The Company vigorously defended these proceedings and following an adjournment the case has been held over. Since 2012, no further action appears to have been taken.
