

#### **Stock**

#### **Prescribed Part**

The Prescribed Part (Section 176(A) of the Act) is a proportion of floating charge asset realisations, net of costs, which are set aside for the benefit of unsecured creditors. The Prescribed Part applies to floating charges created on or after 15 September 2003 only

The Prescribed Part is calculated using a formula laid down in the Act as follows

- 50% of the net property up to £10,000,
- 20% of the net property in excess of £10,000,
- Subject to a maximum amount of £600,000

We estimate, to the best of our knowledge and belief based on the information known to date, that

- The value of the Company's net property, before any costs, is £39,201.87, and
- The value of the prescribed part of the net property will be in the region of £10,840.37

The Prescribed Part is not applicable in this instance as there is no debt due to the floating charge holder, and as such, any funds available under the floating charge will be available to the unsecured creditors
