The consequences of opting-out

Most future documents will not be sent to creditors by post. Nevertheless, the Liquidator is required to inform creditors of their rights to opt out of receiving documents.

Creditors have the right to elect to opt out of receiving further documents about the Liquidation unless:

- (i) the Insolvency Act 1986 requires a document to be delivered to all creditors without expressly excluding opted-out creditors;
- (ii) it is a notice relating to a change in the office-holder or the office-holder's contact details; or
- (iii) it is a notice of a dividend or proposed dividend or a notice which the court orders to be sent to all creditors or all creditors of a particular category to which the creditor belongs.

1 Introduction

- 1.1 This report provides an update on the progress of the liquidation of NC Services Limited (“the Company”).
- 1.2 At Appendix A is my Receipts and Payments Account for the last reporting period of the liquidation, the year from 20 January 2017 to 19 January 2018 and cumulatively for the period of the liquidation to 19 January 2018 together with a comparison of the Directors’ Statement of Affairs values showing a balance in hand of £11,839.
- 1.3 The Company’s registered number is 05764218.
- 1.4 The Company traded from two garages at Molash Garage, The Street, Molash, Canterbury, Kent CT4 8HE and Thannington Motors, 136 Cockering Road, Thannington, Canterbury, Kent CT1 3UA.
- 1.5 Its registered office was Bank Chambers, 156 Main Road, Biggin Hill, Westerham, Kent TN16 3BA but it has since been changed to my office.
- 1.6 I, Andrew James Hawksworth, of Augusta Kent Limited, The Clocktower, Clocktower Square, St George’s Street, Canterbury, Kent CT1 2LE was appointed Liquidator of the Company on 20 January 2015.
- 1.7 I am licensed to act as an insolvency practitioner in the UK by the Institute of Chartered Accountants in England and Wales and my license number is 9582.

2 Realisation of assets

- 2.1 The main asset detailed within the Company’s statement of affairs was its fleet of motor vehicles. The motor vehicles were valued by my agents Landwood Group at £35,100 with an estimated to realise value of £25,650. Some of the motor vehicles were purchased by the Company’s former directors as detailed below:
- 2.2 Andrew Freeland (director and shareholder of the Company) offered £3,300 plus VAT for three of the Company’s motor vehicles. These amounts compare to the valuation obtained prior to the meeting of creditors from Messrs Landwood Group, chartered surveyors and chattel agents, of between £2,750 & £4,650 for these motor vehicles. The sale was concluded upon Landwood Group’s recommendation once the costs of collection and sale by auction were considered on 23 January 2015.
- 2.3 Neil Coates (director and shareholder of the Company) made an offer for two vehicles for £890 plus VAT. These amounts compare to the valuation obtained prior to the meeting of creditors from Messrs Landwood Group, chartered surveyors and chattel agents, of between £950 & £1,550 for these motor vehicles. The sale was concluded on 30 January 2015 upon Landwood Group’s recommendation once the costs of collection and sale by auction were considered.

- 2.4 The remaining vehicles were sold at auction for £20,060. £2,000 had been held by my agents in the event of any future costs arising as a result of the sale of the motor vehicles which has been paid into the estate since my last report.
- 2.5 The directors also detailed a loan account of £9,500 and cash at bank totalled £8,086.
- 2.6 The final accounts have now been written up and are awaiting approval by the former directors. Once the accounts have been approved we will be able to take steps to conclude the liquidation.

3 Investigations

- 3.1 I can confirm that I have completed my duties under the Company Directors Disqualification Act 1986. The contents of this report are confidential and cannot be disclosed. However, I can confirm that the following matters have been investigated:
- 3.2 The misuse of company funds was alleged by both directors. Further investigations have taken place into these whilst preparing the final accounts.
- 3.3 Unfortunately Mr Coates failed to complete a questionnaire I sent him which was reported to The Insolvency Service.

4 Creditors

- 4.1 The directors estimated creditors' claims at £25,600 within the Statement of Affairs. Claims of £5,043 have been received to date.
- 4.2 As stated above the final accounts have been written up and are waiting to be agreed by the former directors. Once agreed we can submit the final returns to HM Revenue & Customs who will then provide an updated claim.

5 Liquidators remuneration

- 5.1 At a meeting of creditors held at 20 January 2015, creditors approved, as an expense of the liquidation, payments £4,000 plus disbursements and VAT to Augusta Kent Limited in respect of the preparation of the Statement of Affairs.
- 5.2 At the same meeting, creditors approved a resolution for the Liquidators remuneration to be fixed according to the time costs of him and his Staff. Attached at Appendix B is a Time Analysis in accordance with the provisions of Statement of Insolvency Practice 9, which provides details of the activity costs incurred by staff grade to date.


5.3 The Liquidator's post-appointment time costs as at 19 January 2018 total £18,329.00 representing 129.0 hours at an average rate of £142.09 per hour. Post-liquidation fees of £11,084.50 have been drawn and no further fees have been drawn in the reporting year.

5.4 The following expenses have also been incurred by the Liquidator during the liquidation to date.

Appendix C

Additional Information in Relation to Liquidator's Fees Pursuant to Statement of Insolvency Practice 9

I Policy

Detailed below is our policy in relation to:

- staff allocation and the use of sub-contractors;
- professional advisors; and
- disbursements.

1.1 Staff Allocation and the use of Sub-contractors

Our general approach to resourcing our assignments is to allocate staff with the skills and experience to meet the specific requirements of the case.

The constitution of the case team will usually consist of the office-holder and one or more junior staff. The exact constitution of the case team will depend on the anticipated size and complexity of the assignment and on larger, more complex cases, several Administrators may be allocated to meet the demands of the case. With regard to support staff, we would advise that time spent by cashiers in relation to specific tasks on an assignment is charged. We have not utilised the services of any sub-contractors in this case.

1.2 Professional Advisors

On this assignment we have used the professional advisors listed below. Our choice was based on our perception of their experience and ability to perform this type of work, the nature of the assignment and the basis of our fee arrangement with them.

1.3 Disbursements

Category 1 disbursements do not require approval by creditors. The type of disbursements that may be charged as a Category 1 disbursement to a case generally comprise of external supplies of incidental services specifically identifiable to the case, such as postage, case advertising, invoiced travel and external printing, room hire and document storage. Also chargeable will be any properly reimbursed expenses incurred by personnel in connection with the case.

Category 2 disbursements do require approval from creditors. These disbursements can include costs incurred which relate to payments due to associated companies for the provision of services to the office-holder. Our policy for recharging is as follows:

Creditors' and members' requests for further information in administration, winding up and bankruptcy

Rule 18.9

- (1) The following may make a written request to the office-holder for further information about remuneration or expenses (other than pre-administration costs in an administration) set out in a progress report under rule 18.4(1)(b), (c) or (d) or a final report under rule 18.14—
 - (a) a secured creditor;
 - (b) an unsecured creditor with the concurrence of at least 5% in value of the unsecured creditors (including the creditor in question);
 - (c) members of the company in a members' voluntary winding up with at least 5% of the total voting rights of all the members having the right to vote at general meetings of the company;
 - (d) any unsecured creditor with the permission of the court; or
 - (e) any member of the company in a members' voluntary winding up with the permission of the court.
- (2) A request, or an application to the court for permission, by such a person or persons must be made or filed with the court (as applicable) within 21 days of receipt of the report by the person, or by the last of them in the case of an application by more than one member or creditor.
- (3) The office-holder must, within 14 days of receipt of such a request respond to the person or persons who requested the information by—
 - (a) providing all of the information requested;
 - (b) providing some of the information requested; or
 - (c) declining to provide the information requested.
- (4) The office-holder may respond by providing only some of the information requested or decline to provide the information if—
 - (a) the time or cost of preparation of the information would be excessive; or
 - (b) disclosure of the information would be prejudicial to the conduct of the proceedings;
 - (c) disclosure of the information might reasonably be expected to lead to violence against any person; or
 - (d) the office-holder is subject to an obligation of confidentiality in relation to the information.
- (5) An office-holder who does not provide all the information or declines to provide the information must inform the person or persons who requested the information of the reasons for so doing.
- (6) A creditor, and a member of the company in a members' voluntary winding up, who need not be the same as the creditor or members who requested the information, may apply to the court within 21 days of—
 - (a) the office-holder giving reasons for not providing all of the information requested; or
 - (b) the expiry of the 14 days within which an office-holder must respond to a request.
- (7) The court may make such order as it thinks just on an application under paragraph (6)

Remuneration and expenses: application to court by a creditor or member on grounds that remuneration or expenses are excessive

Rule 18.34

- (1) This rule applies to an application in an administration, a winding-up or a bankruptcy made by a person mentioned in paragraph (2) on the grounds that—
 - (a) the remuneration charged by the office-holder is in all the circumstances excessive;
 - (b) the basis fixed for the office-holder's remuneration under rules 18.16, 18.18, 18.19, 18.20 and 18.21 (as applicable) is inappropriate; or
 - (c) the expenses incurred by the office-holder are in all the circumstances excessive.
- (2) The following may make such an application for one or more of the orders set out in rule 18.36 or 18.37 as applicable—
 - (a) a secured creditor,
 - (b) an unsecured creditor with either—
 - (i) the concurrence of at least 10% in value of the unsecured creditors (including that creditor), or
 - (ii) the permission of the court, or
 - (c) in a members' voluntary winding up—
 - (i) members of the company with at least 10% of the total voting rights of all the members having the right to vote at general meetings of the company, or
 - (ii) a member of the company with the permission of the court.
- (3) The application by a creditor or member must be made no later than eight weeks after receipt by the applicant of the progress report under rule 18.3, or final report or account under rule 18.14 which first reports the charging of the remuneration or the incurring of the expenses in question ("the relevant report")
