



NOTES TO THE DIRECTOR'S STATEMENT OF AFFAIRS

1. COSTS

The directors Statement of Affairs does not include a provision for the costs associated with its preparation convening of the meeting of creditors and agreeing the creditors claims or for agents fees and professional costs associated with realising the company's assets

2. OFFICE FURNITURE

The book value for the office furniture has been uplifted from the latest set of accounts and relates to one chair. It is believed that this asset has a negligible value

3. COMPUTER EQUIPMENT

The book value for the computer equipment has been uplifted from the latest set of accounts and relates to one computer. It is believed that this asset has a negligible value

4. STOCKS

The book value for stock relates to work in progress and has been uplifted from the latest set of accounts, although this has changed significantly whilst trading continued. No value remains.

5. DEBTORS


The debtors figure has been uplifted from the latest set of accounts and will have changed significantly up to the cessation of trade. The director has advised that this has all been repaid, with the exception of one debtor where payment is being made to this office

6. HOT BUTTON MARKETING LIMITED

The figure has been uplifted from the latest set of accounts and relates to a balance due from an associated company, Hot Button Marketing Limited. J Langley is both a director of Hot Button Marketing Limited and El Fandango Limited. This balance has changed significantly up to the cessation of trade, and it is believed that only £5,654 remains outstanding. No realisation is expected as the company has also ceased trading and has no assets

7. PREPAYMENTS

The company has accrued prepayments, however, there is no realisable value for this asset



8. CASH AT BANK

The company holds an account with Santander UK Plc, this figure represents the credit balance

9. PRESCRIBED PART OF NET PROPERTY

The company has not granted any security over its assets, therefore the estimated prescribed part calculation is not applicable

10. TRADE & EXPENSE CREDITORS

These amounts which include V.A T where appropriate, have been extracted from the company's records and therefore must not be regarded as agreed amounts.

14. DIRECTOR'S LOAN ACCOUNT


This represents funds advanced to the company by the director in order to support continued trading
