





1. Sale Smith & Co Limited On 11th April 2013, instructions were given to Messrs Sale Smith & Co. Limited to convene a statutory meeting of the creditors of the company, following the director's decision to commence the voluntary winding up proceedings of the company. Neither Mrs Eileen Sale nor any member of the firm Sale Smith & Co Limited has previously acted for the company or any director thereof
2. Book Debts Information relating to the company's outstanding book debts has been provided by the director. A general provision of 25% has been made by the director in respect of bad or doubtful debts


