**NOTES TO THE STATEMENT OF AFFAIRS**

---

These notes are prepared as a guide to explain some of the items within the Statement of Affairs. It will be a matter for the duly appointed liquidators to investigate all such items in due course

- 1 The Statement of Affairs is prepared prior to the application of the costs of Liquidation
2. Book values are taken from the Financial Statements for the period ending 30 June 2014 unless stated otherwise.
- 3 Royal Bank of Scotland Invoice Finance created an all assets debenture on 03 March 2008 and this has been duly registered at Companies House on 04 March 2008. The outstanding balance due represents a consolidation of an overdrawn bank account and a business loan. This has been personally guaranteed by the director. It will be for the duly appointed liquidators to investigate.
- 4 Calverton Factors Limited created an all assets debenture on 11 May 2010 and this has been duly registered at Companies House on 27 May 2010. No factored book debts remain outstanding and no money is due to the chargeholder. It will be for the duly appointed liquidators to investigate.
- 5 The garage plant and machinery was shown in the financial statements to have a realisable value of £13,238. This consists of equipment for repairs of vehicles including a spray booth and a jig. The assets have been independently valued by Griffin James Limited (Asset Consultants) who have estimated an ex-situ value of £4,000. It will be for the duly appointed liquidators to investigate
- 6 The Furniture and Equipment consists of office furniture and computer equipment that was shown in the financial statements to have a realisable value of £0. The assets have been independently valued by Griffin James Limited (Asset Consultants) who has estimated an ex-situ value of £40. It will be for the duly appointed liquidators to investigate
7. The motor vehicles represent two courtesy cars (Ford Fiesta and a Citroen Berlingo) that were shown in the financial Statements to have a realisable value of £4,461. The assets have been independently valued by Griffin James Limited (Asset Consultants) who has estimated an ex-situ value of £650. It will be for the duly appointed liquidators to investigate

An offer has been received from a third party prior to the appointment of the liquidators of £4,000 plus VAT for all of the assets less the Spray Booth which was recommended to, and accepted by the director. Additionally another third party has offered £3,000 plus VAT for the spray booth again this was recommended to and accepted by the director. The combined offer is in excess of the agent's ex-situ valuation.

- 8 The director has provided an up to date figure in respect of the sales ledger being £16,340, this is subject to insurers fees of £2,302. The statements of affairs estimate that 75% of the ledger after fees will be realisable. It will be for the duly appointed liquidators to investigate
9. The cash at bank represents the balance currently held in its business account, no balance was shown in the financial statements. It will be for the duly appointed liquidators to investigate.
- 10 The preferential element of the employees that worked for the company is in respect of Arrears of Pay (maximum of £800 and Holiday Pay) The unsecured element of the employees claim is in respect of Pay in Lieu of notice (prior to mitigation) and Redundancy Pay. This includes the amount due to the director of the Company where applicable. It will be for the duly appointed liquidators to investigate these claims
- 11 The director claim includes loans to Company by way of a loan (£15,000) and the purchase of stock on personal credit cards (£30,423.23). It will be for the duly appointed liquidators to investigate and agree claims
12. Unsecured creditor claims are stated inclusive of VAT, where applicable. It will be a matter for the duly appointed liquidators to investigate and agree claims.
- 13 Amounts due to HM Revenue and Customs in respect of Corporation Tax, PAYE, NI and VAT represent monies due for period outstanding from the period ended 05/08/2013 onwards. It will be for the duly appointed liquidators to investigate and agree claims
