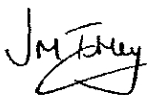

NOTES TO THE ESTIMATED STATEMENT OF AFFAIRS

All book values have been taken from the Company's latest financial information or from valuations obtained from independent valuers. It should be noted that no provision has been made for the costs of preparation of the same, the costs of convening the meetings of members and creditors, agents' costs or the costs and expenses of the Liquidation.

1. Goodwill

The Financial Statements for the year ended 31 March 2011 show that Goodwill had a book value of £40k, for the purpose of this report the estimated to realise value has been shown as Nil.

2. National Westminster Bank Plc

National Westminster Bank Plc holds a fixed and floating charge against the Company created on 26 April 2011 and Registered on 30 April 2011. The Company's current indebtedness to National Westminster Bank Plc amounts to approximately £90,000.

3. Debtors & Retentions

The book value of the Debtors & Retentions ledger has been provided from information in the Company books and records and from information provided by the director. The ledger has been valued by an independent Quantity Surveyor, who estimates the ledger to realise a sum of £67,500.

4. Plant & Machinery

The book value of the Plant and Machinery has been extracted from the Company's balance sheet as at 31 March 2011, with no provision for amortisation having been applied for the period since that date. The director has provided the estimated to realise value for the purpose of the Statement of Affairs.

5. Motor Vehicles

The Motor Vehicles have been subject to an independent valuation by the firm Charles Taylor, who have been provisionally instructed by the nominated liquidators. The book value and estimated to realise value have been extracted from the valuation report for the purpose in the Statement of Affairs. The company also utilised a vehicle subject to a lease hire agreement, which has not been shown on the Statement of Affairs.


6. Office Furniture & Equipment

The Office Furniture & Equipment have been subject to an independent valuation by the firm Charles Taylor, who have been provisionally instructed by the nominated liquidators. The book value and estimated to realise value have been extracted from the valuation report for the purpose in the Statement of Affairs.

7. Preferential creditors

The Company had 9 employees who will be entitled to claim arrears of pay and holiday pay (subject to certain limits) from the Redundancy Payments Office ("RPO") (a government department). The RPO will then lodge a preferential claim against the Company in respect of the payments it has made. Preferential claims have been estimated at £9,000 for the purposes of the statement of affairs.

Employees will also be able to lodge redundancy claims and compensation claims as a result of not receiving statutory notice of redundancy with the RPO. These claims will also be paid by the RPO (subject to certain limits), who will lodge an unsecured claim against the Company.

NOTES TO THE ESTIMATED STATEMENT OF AFFAIRS (cont.)

8. Prescribed part

The Insolvency Act 1986 provides that, where a company has created a floating charge after 15 September 2003, a prescribed part of the company's net property must be made available to the unsecured creditors and not be distributed to the floating charge holder except in so far as it exceeds the amount required for the satisfaction of unsecured claims

The method of calculating the prescribed part is given below

Where the net property does not exceed £10,000

50% of that property

Where the net property exceeds £10,000

50% of the first £10,000, plus 20% of the property, which exceeds £10,000, up to a maximum prescribed part of £600,000

The prescribed part has been calculated as per the statement of affairs, however, the value of the net property will be subject to the level of realisable assets and the costs and expenses of the insolvent liquidation process. Subject to the value of the net property being in excess of £10,000 it is estimated that a prescribed part may be available

9. H M Revenue & Customs – PAYE / NI & VAT

The liability to HMRC in respect of unpaid PAYE, NIC and VAT has been extracted from the Company's books and records. The outstanding liabilities are in respect of the following periods
