



NOTES TO THE ESTIMATED STATEMENT OF AFFAIRS

All book values have been taken from the Company's latest financial information, information provided by the directors or from valuations obtained from independent valuation agents. It should be noted that no provision has been made for the costs of preparation of the same, the costs of convening the meetings of members and creditors, agents' costs or the costs and expenses of the Liquidation.

1. National Westminster Bank Plc

National Westminster Bank Plc hold a debenture incorporating a fixed & floating charge created on 04 June 2010 and registered on 10 June 2010. Although this charge is still showing as unsatisfied on Company's House, the director has advised that this charge has been satisfied in full.

2. Fixtures, Fittings and Equipment

The book values of the fixtures, fittings & equipment have been extracted from the Company's financial statements as at 31 December 2010. The assets have been written down to an estimate to realise value of £1,250 for the purposes of the statement of affairs.

3. Preferential creditors

No employee claims are estimated to arise as it is understood that all the Company's employees were made redundant and paid up in full by the Directors. No preferential claims are estimated to arise as a result of the insolvent liquidation.

4. Prescribed part

The Insolvency Act 1986 provides that, where a company has created a floating charge after 15 September 2003, a prescribed part of the company's net property must be made available to the unsecured creditors and not be distributed to the floating charge holder except in so far as it exceeds the amount required for the satisfaction of unsecured claims.

The method of calculating the prescribed part is given below

Where the net property does not exceed £10,000

50% of that property

Where the net property exceeds £10,000

50% of the first £10,000, plus 20% of the property which exceeds £10,000, up to a maximum prescribed part of £600,000

The value of the net property after costs is expected to be less than the prescribed minimum and as such the provision for setting aside a prescribed part is not considered applicable in these circumstances for the purposes of the statement of affairs.

5. H M Revenue & Customs – PAYE / NI

The liability to HMRC in respect of unpaid PAYE, NIC has been extracted from the Company's books and records. The outstanding liabilities are in respect of the following periods, as the Company was subject to a time to pay arrangement with HMRC
