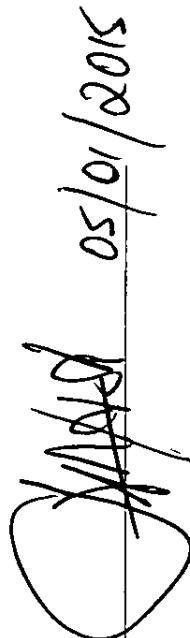

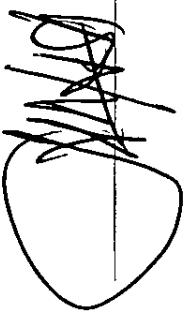

Notes to Statement of Affairs

1 Patents

The company has an IP portfolio that includes a fully granted GB patent that has lapsed. A number of divisional patents have been filed for other countries and it has a fully registered trademark listed in many countries. For the purposes of the statement of affairs the recommended to realise figure has been shown as uncertain, due to the fact there have been several valuations, none of which have been provided on a forced sale basis and all of which are vastly different.

2. Plant & Machinery and Furniture & Equipment

The Company owned a small quantity of plant & machinery, computer equipment and fixtures and fittings held at the trading premises with a net book value, in the February 2014 accounts totalling £23,230. Independent agent, Kumar & Company, have provided the Board with a going concern valuation, of £23,000, however given the fact that these assets are likely to form part of a forced sale, due to the liquidation, the value used for the statement of affairs, is £11,500 (50% of the going concern value). The duly appointed liquidator will need to arrange for further inspection and sale of these assets.

3 Book Debts

As at the 2 January 2015 the Company's books and records showed outstanding book debts in the sum of £7,000. The directors have advised that they are not aware of any bad or doubtful debts or reasons that this sum of will not be paid in full. The standard terms of settlement are 60 days from invoice and therefore these sums are due for payment on or before the 31 January 2015.

4. Stock / WIP

The directors have advised that there is a small amount of residual stock at the trading premises, this comprises of both part finished product and consumables. The value of items, is uncertain, and therefore will require reviewing by agents prior to the sale and disposal. The duly appointed liquidator will arrange this.

5. Cash at Bank

The Company's bank account held a credit balance of £2,259 18 on the 3 January 2015.

6 Trade & Expense Creditors

There are sums owed to trade and expense creditors estimated to total £62,334 19.

7. Employees

In respect of the employees claims for wages and holiday pay £1,600 represents preferential claims and fall to be settled in full in accordance with statute before claims of unsecured non-preferential creditors.

The balance of claims relate to redundancy and lieu of notice where applicable

8 Shareholders and Former Director

An estimated balance of £55,000 is due to one shareholder and a former director in respect of loans made to the Company

6. Bank

The sum of £34,700 is due to Lloyds Bank plc ("Lloyds") in relation to an EFG loan provided in April 2011. Therefore, Lloyds hold a fixed and floating charge over the Company's assets

The outstanding loan in respect of the small business guarantee scheme and the Enterprise Loan guarantee will be recoverable from the relevant government department

7. HM Revenue & Customs
