The fork lift has a damaged head gasket which has an estimated cost to fix of approximately £1,000 This is reflected in the estimated to realise figure

### **Cash in Hand**

The Company sold some assets pre Liquidation to a former employee The monies are held in an agent's client account The duly appointed Liquidator will ratify the sale to ensure it was sold at true value

### **Cash at Bank**

The Company holds a small credit balance account

### **Furniture & Equipment**

Correspondence is currently ongoing with a creditor who has distrained over the assets of the Company It is unclear if the bailiffs will proceed with this matter
