There is therefore an estimated deficiency to creditors of £71,170 and taking into consideration the share capital of £2, there is a total estimated deficiency of £71,172

Scaffolding equipment with a net book value of £11,356 was sold for £3,000 and motor vehicles with a net book value of £20,512 were sold for £7,000 Outstanding finance amounted to £13,059 All receipts were paid into the company bank account These sales were to an unconnected party

The Prescribed Part

Under normal circumstances because the Close Invoice Finance charge is dated after September 2003 there would be a deduction under the Prescribed Part Order 2003 However because there are no preferential creditors the total surplus after paying the secured creditor will be available for unsecured creditors

TRANSACTIONS WITH RELATED PARTIES

Mr Lee Tickner who is a director of the company is a creditor by way of his claim for unpaid expenses in the sum of £1250 00
