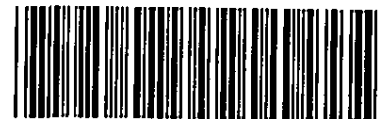



- 3 The cash in hands of accountants relates to monies held in the Redman Nichols Butler client account which has been transferred from the company's bank account

- 4 The cash in hands of agents refers to monies held by C W Harrison following the sale of the company's chattel assets by way of online auction
C W Harrison were appointed by the landlord to recover the arrears of rent and levied distriant on the company's assets in February 2014
It is undertsood that there are a number of other High Court enforcement offices claiming these monies This will be considered by the duly appointed liquidator
