




**NOTES TO DIRECTOR'S ESTIMATED STATEMENT OF AFFAIRS**

**AS AT 15 MAY 2015**

- 1 The Company's bank account, which is held at Lloyds Bank plc, is in credit in the amount of £7
- 2 Whilst the Company's books and records do not disclose a value attributed to Work in Progress ("WIP"), the Director believes there to be a value attributable to the same, which could be as high as £256,400. This relates to commitments made by clients for which funds have not been remitted. As a result of the Company's insolvency, it will be unable to fulfil the obligations to the artists and, therefore, to the clients and its WIP is expected to have no realisable value unless a purchaser for the business can be found.
- 3 The Company's records disclose an amount due to it by Mr Gold of £19,393, which will need to be verified by the duly appointed Liquidators. It is not currently known whether Mr Gold is in a position to discharge this debt. Accordingly, it is shown within the Statement of Affairs as having an uncertain estimated to realise value.
- 4 The Company has no salaried employees and, accordingly, is unlikely to have any Preferential Creditors.
- 5 HM Revenue & Customs is owed £16,789 in relation to unpaid Corporation Tax.
- 6 The Company's current liability to HM Revenue & Customs in respect of unpaid VAT is unknown. Once appointed, the Liquidators will need to establish the Company's VAT position.
- 7 The Estimated Total Deficiency is subject to the costs and expenses of the liquidation.


