



**NOTES TO THE ESTIMATED STATEMENT OF AFFAIRS**

All book values have been taken from valuations obtained from independent valuation agents. It should be noted that no provision has been made for the costs of preparation of the same, the costs of convening the meetings of members and creditors, agents' costs or the costs and expenses of the Liquidation.

**1. Assets Specifically Pledged**

**Motor Vehicle**

The book value as stated for the motor vehicle, being an Iveco pick-up truck registration number YJ61 EBO, represents the reinstatement cost assessment figure as per appointed agents Cerberus Asset Management's valuation report dated 9 February 2015 ("CAM's report"). This asset is subject to a finance agreement.

The estimated to realise figure as stated represents the forced sale figure as per CAM's report.

**2 Assets Not Specifically Pledged**

**Office Furniture and Equipment**

The book value as stated for these assets, which includes seven PC base units and monitors, represents the reinstatement cost assessment figure as per CAM's report.

The estimated to realise figure as stated represents the forced sale figure as per CAM's report.

**Equipment**

The book value as stated for these assets, which includes a Toyota 2.5 tonne counter balance forklift, represents the reinstatement cost assessment figure as per CAM's report.

**Motor Vehicle**

The book value as stated for the motor vehicle, being a Mercedes Atego registration number KX57 HCD, represents the reinstatement cost assessment figure as per CAM's report.

**Cash at Bank**

The Company operated a bank account with Lloyds TSB Bank plc ("the Bank"). The current balance at bank is approximately £100.

**Retentions**

The book value as stated, represents the gross value owed to the Company as per appointed agents Cerberus Receivables Management ("CRM") report dated 6 February 2015.

CRM have advised that recoveries of between nil and £10,000 are likely. A mid range figure has been used for the estimated to realise figure.

**3 Employee Claims / ERA'2006 Claims (est.)**

Where applicable, employees will be entitled to make claims (subject to certain limits) under the Employment Rights Act 2006 (ERA'2006) from the government department known as the Redundancy Payments Service ("RPS"). The Employee claims may include arrears of pay, holiday pay, compensation in lieu of notice and redundancy. Where applicable, the RPS will make payments directly to the employees and then the RPS will then lodge a claim against the Company in respect of the payments it has made. Employee Claims / ERA'2006 have been estimated for the purposes of the statement of affairs and are not considered as agreed amounts.

The only employees of the Company are the two directors, Mark Horngan and James Galvin.

**4. Prescribed Part**

As the Company has no unsatisfied post-Enterprise Act charges, there will be no requirement to set aside a prescribed part in this case.

**5. H M Revenue & Customs**

The liability to HMRC in respect of unpaid PAYE, NIC, VAT and corporation tax has been estimated by the director. The outstanding liabilities are in respect of the following periods:

PAYE /NIC /CIS- January 2015,  
VAT – December 2014 - January 2015, and  
Corporation Tax – 1 April 2013 to 31 March 2014

**6. Directors' Loans**


