

ASSETS SPECIFICALLY PLEDGED

The only such asset is a Transporter Motor Vehicle subject to an outstanding hire purchase agreement and in which there is not expected to be any equity

ASSETS NOT SPECIFICALLY PLEDGED

These comprise improvements to premises, another Transporter already written off, some debtors and cash at bank

The improvements are impossible to realise, the Transporter is of scrap value only and the cash at bank represents debtors who have already paid. There are four outstanding debtors, one of which is a possible bad debt of £15,300 leaving a potential recovery of £2,074

The tangible assets have not been valued and the successor company is interested in acquiring them




