

NOTES TO THE ESTIMATED STATEMENT OF AFFAIRS

All book values have been taken from the Company's latest financial information provided by the director, or from valuations obtained from independent valuation agents. It should be noted that no provision has been made for the costs of preparation of the same, the costs of convening the meetings of members and creditors, agents' costs or the costs and expenses of the Liquidation.

1. Assets Specifically Pledged

There are no assets which are specifically pledged.

2 Assets Not Specifically Pledged**Intangible Fixed Assets**

The financial statements for the year ended 30 September 2013 show intangible fixed assets with a book value of £2,515. The estimated to realise value has been shown as £uncertain for the purposes of the statement of affairs.

Plant and Machinery

The financial statements for the year ended 30 September 2013 show tangible fixed assets, categorised as plant and machinery with a book value of £64,072. It is understood that the assets relate to motor vehicles fitted with cleaning equipment and the director has indicated that the assets are subject to lease / hire agreement (s) and the Company has no beneficial interest in the assets. The estimated to realise value has been shown as £Nil for the purposes of the statement of affairs.

Debtors

The book value of debtors has been provided by the director. It is understood that the outstanding debtors are due from the franchisor and it is likely that the franchisor will seek to apply set off against the amount that they are owed from the Company under the franchise agreement. The estimated realise value has been shown as £Nil for the purpose of the Statement of Affairs.

Director's Loan Account

The book value of the director's loan account has been provided by the director and relates to Peter Foster. The estimated realisable value has been shown as uncertain for the purposes of the statement of affairs.

3 Employee Claims / ERA'2006 Claims (est)

Where applicable, employees will be entitled to make claims (subject to certain limits) under the Employment Rights Act 2006 (ERA'2006) from the government department known as the Redundancy Payments Service ("RPS"). The Employee claims may include arrears of pay, holiday pay, compensation in lieu of notice and redundancy. Where applicable, the RPS will make payments directly to the employees and then the RPS will then lodge a claim against the Company in respect of the payments it has made. Employee Claims / ERA'2006 have been estimated for the purposes of the statement of affairs and are not considered as agreed amounts.

4 Prescribed Part


As the Company has no unsatisfied post-Enterprise Act charges, there will be no requirement to set aside a prescribed part in this case.

The method of calculating the prescribed part is given below.

Where the net property does not exceed £10,000 (the prescribed minimum) it may be considered that the cost of making a distribution is disproportionate to the benefits and no prescribed part is required to be set aside.

Where the net property exceeds £10,000 the prescribed part is calculated at a value of 50% of the first £10,000 plus a further 20% of the net property which exceeds £10,000, up to a maximum prescribed part of £600,000.
