4 NOTES TO THE ESTIMATED STATEMENT OF AFFAIRS AS AT 12 DECEMBER 2012

Assets

Assets Specifically Pledged.

4.1 The Director advised that all assets were either damaged in the floods or have been the subject of distress by the Landlord, save for some of the operational assets which Leachys held a lien over. Details of the assets taken by Leachys have yet to be disclosed.

Assets not Specifically Pledged.

4.2 Insurance Claim

The Director advised that an insurance claim has been submitted however all documentation pertaining to the insurance claim has either been destroyed in the floods or discarded by the Landlord. Accordingly, no further information has been received to pursue any potential claim at this juncture.

Creditors

4.3 Preferential Creditors

There are 8 employees each owed two weeks of wages and who may also be due some holiday pay. The total amounts due to these employees in these regards have yet to be quantified.

The director also advises that 1 further employee who is due two weeks of wages, is also entitled to Holiday Pay in the sum of £2,500.

The figure included in the Statement of Affairs therefore represents the statutory maximum of £800 per employee with regards to remuneration, together with £2,500 in respect to the Holiday Pay which will constitute a preferential claim.

4.4 Prescribed Part

Not applicable as the company did not grant a floating charge.

4.5 HM Revenue & Customs

The director has estimated that the company has a post Company Voluntary Arrangement (CVA) debt with H M Revenue and Customs of £12,000 in regards to PAYE and NIC (ie debt incurred post September 2011)

A further £14,000 is owed to them in relation to VAT in respect of post CVA periods

In addition, H M Revenue and Customs had submitted claims in the CVA of £15,859.73 with regards to PAYE and NIC and £14,600 with regards to VAT, in respect of debts accrued pre September 2011

The figures included in the Statement of Affairs therefore represent all figures detailed above

4.6 Trade and Expense Creditors

The amounts stated in the statement of affairs have been taken from those supplied at the commencement of the failed CVA where claims have not been received from creditors during the term of the CVA, together with post arrangement creditors supplied by the director who believes that these creditors have outstanding monies owed to them. The figure detailed in the estimated Statement of Affairs is subject to the agreement of creditors' claims. Creditors' amounts include VAT where applicable

4.7 Director's Loan Accounts

This represents funds advanced by the director. The amount shown in the statement of affairs is that which was outstanding at the commencement of the failed Company Voluntary Arrangement. The actual balance is uncertain and it is considered prudent to show the last known balance

4.8 Employee Claim

This represents the estimated liability in respect of pay in lieu of notice due to the employee. Given that the company has been trading for less than 2 years, it is not anticipated there will be any liability in respect of redundancy

4.9 General

The estimated Statement of Affairs is subject to the Liquidator's costs and disbursements and the costs of the agents and solicitors employed by the Liquidator
