

DIRECTORS' HISTORY OF THE BUSINESS AND ANY OTHER MATTERS

Background

Acjen was formed in October 2010 by myself with help from Mark Jenkins who had a background in plastic fabrication. My role in the company was administrative. I opened a business bank account with Lloyds Bank in Bridgend. We have never had an overdraft, loan or credit/debit cards.

Initially the company rented space in a unit in David Street on Bridgend Industrial Estate from APW Property, included in the rental was the use of the machinery which was in situ. The level of business was variable and we were regularly being chased by our suppliers for payment although business did improve slightly during 2012.

However, in 2013 the landlord sold the premises from which we were trading and we were left looking for new premises, this took some time during which we could not fulfil orders and take on new work. Eventually we found premises on the Waterton Industrial Estate which we rented from Wyndham Plastics and went about trying to catch up on the business we had lost during the previous few months.

In November 2014 Wyndham Plastics went into liquidation so, once again, we found ourselves with nowhere from which to trade and as we owed Wyndham Plastics rent they took our remaining small tools etc in lieu of the rent that was owing. At this point we decided it would be impossible to continue.

Insolvency Advice

In February 2015 the directors sought advice from Hawkins and Company, who confirmed that Acjen Laser Services Limited was insolvent within the meaning of s123 of the Insolvency Act 1986 and should be wound up. Subsequently a meeting was held on the 17th February 2015 and the appropriate notices were signed and dispatched to members and creditors.

Cost associated with the liquidation

A fee of £4,000 plus VAT and disbursements has been agreed with Hawkins and Company for assisting in the preparation of this report and the Statement of Affairs and convening meeting of members and creditors.

Other Matters

This report and Statement of Affairs has been compiled by Hawkins and Company from the information provided by the directors and has been approved by the directors for circulation.
