



NOTES TO THE ESTIMATED STATEMENT OF AFFAIRS

All book values have been taken from the Company's latest financial information or from valuations obtained from independent valuation agents. It should be noted that no provision has been made for the costs of preparation of the same, the costs of convening the meetings of members and creditors, agents' costs or the costs and expenses of the Liquidation.

1. Assets Specifically Pledged

There is a debenture with The North West Fund 4 Business Loans which incorporates certain fixed and floating charges. There are no assets however considered to be within the Company that would be covered by a fixed charge.

2. Charge Holder

There is a debenture in existence with North West Fund 4 Business Loans. This debenture relates to a cross guarantee provided by Agency 2 Payroll Limited in relation to monies borrowed by the associated company, Liverpool Recruitment Company Ltd.

The debenture was created on 16 February 2012 and registered at Companies House on 28 February 2012. The debenture provides for fixed and floating charges over the undertaking of the business.

3. Assets Not Specifically Pledged

The Company banks with Barclays Bank Plc and the balance on the account is currently less than £1.

4. Liverpool Recruitment Company Ltd

The information provided indicates that the intercompany debt is £180,000 but there is a contra charge in relation to the three years management fees of £109,000 therefore resulting in the net balance of £71,000.

It is understood that Liverpool Recruitment Company Ltd will be placed into administration and it is unlikely that there will be any dividend available for any class of creditor.

5. Employee Claims / ERA'2006 Claims (est.)

It is not envisaged that there will be any claims made by employees in respect of arrears of pay, holiday pay, compensation in lieu of notice or redundancy.

6. Prescribed Part

As the assets are considerably less than £10,000 it is likely that a prescribed part will be dispensed in this matter.

7. HM Revenue & Customs – PAYE / NI & VAT


There is a PAYE and NI liability which dates back to the 5 April 2012 plus a small amount of current tax that had been deducted from employees but not paid over to the crown. We understand that there are CIS refunds due which may reduce this liability to nil.

8. VAT

The VAT liability totals £106,095 covering the period 31 March 2013 to date, includes surcharges totalling £11,383.

9. Trade and Expense Creditors

Details of the Company's trade and expense creditors are relatively small given the nature of the Company's business.
