





Notes to the Statement of Affairs

- 1 A rent deposit deed in the sum of £3,750 has been lodged in respect of the Company's leasehold premises. The duly appointed liquidator will need to liaise with the landlord in respect of this balance and any residual balance after the settlement of outstanding rent and dilapidation costs.
- 2 In accordance with the Company's 2014 accounts, the Company's chattel assets had a net book value of £5,482. In accordance with Kumar and Company's valuation, these assets had an ex-situ valuation of £1,250.
- 3 The Company's 2014 accounts indicated stock with a book value of £22,950. It is understood that the Company currently holds only a residual amount of stock, however, the duly appointed liquidator will need to review this further.
- 4 Pursuant to Section 176A of The Insolvency Act 1986 (as amended), a Prescribed Part of the Company's net assets should be set aside for the benefit of unsecured creditors. This reduces the funds that would otherwise be made available to any secured creditor under Floating Charges created after 15 September 2003.

The Company has not granted any qualifying floating charges and so the prescribed part will not be applicable in this matter.

- 5 The values for trade & expense creditors are taken from the company's books and records. Any variation from the creditors' records may be investigated by the duly appointed Liquidator.
- 6 The inclusion of a claim does not constitute admission of the debt. All claims are subject to formal adjudication.
- 7 The position regarding liabilities to HMRC will need to be established by the duly appointed liquidator following the submission of final returns.
