

Notes to the statement of affairs

- 1 The statement of affairs ignores the costs of insolvency
- 2 Section 176A of the Insolvency Act 1986 (the prescribed part) does apply in this case as there is a floating charge created after 15 September 2003. If the net property is less than £10,000 and the costs of distributing the prescribed part are disproportionate to the benefit then the prescribed part may be disapplied by the subsequently appointed liquidator
- 3 The cash in hands of agents relates to monies held in respect of the sale of the company's chattel assets and are less the costs of the sale. These assets were sold by way of public auction on 13 December 2014
- 4 The 2013 accounts show dividend of £30,000 being paid with a note stating that 'the director acknowledges that the dividends are illegal because there are insufficient reserves and that he could be personally liable to repay the company any shortfall'
This will be looked at by the duly appointed liquidator
- 5 The cash in hands of accountants refers to monies held in the client account of Redman Nichols Butler
- 6 There is a director's loan account due to the company in the sum of £1,509.40. The estimated to realise value is uncertain
This will be considered by the duly appointed liquidator in the usual manner
- 7 The debts due to HM Revenue & Customs are best estimates only
- 8 The inclusion of creditor balances on the statement of affairs is as per the company's records. Claims of creditors will be subject to admission by the duly appointed liquidator in the usual way
