





**Notes to the statement of affairs**

- (1) Office equipment relating to general office supplies have an estimated to realise zero value in the liquidation
- (2) Other equipment is shown in the Company's records as having a book value of £15,824 and relates to a Rigid Inflatable Boat (RIB), Inflatable Billboards and other assorted assets. The RIB and Inflatable Billboards are expected to realise their book values of £10,500 and £5,055 respectively, however, the remaining assets are expected to realise zero value
- (3) A Vauxhall Astra van is owned by the Company and can be expected to realise its book value, however, no professional valuation has yet been undertaken
- (4) Prepayments relate to sponsorship of various boat events already paid, and the charter of a boat for Cowes week 2014. The recoverability of these funds is considered unlikely but will be considered in the liquidation
- (5) An amount remains outstanding from Rule 26 of £36,613. This amount is currently being disputed by Rule 26 and as such it is uncertain as to whether any realisation is likely
- (6) Cash of £10,400 is currently being held by James Cowper LLP in their client account on behalf of the Company. £250 is estimated to be remaining in the Company's bank account
- (7) Debtors equal £37,295 at the date of liquidation, however, a number of the debtors dispute the amounts due and as such £24,439 is estimated by the director as realisable
- (8) There is an outstanding directors loan account of £4,495
- (9) City and County Graphics Limited - a connected company - is a creditor in relation to various salaries and payments made by them on behalf of the Company. It may be possible for City and County Graphics Ltd to make a preferential subrogated wages claim in respect of monies advanced for wages
- (10) Exclusion from the list of creditors does not prevent a creditor from making a valid claim in the liquidation
- (11) Inclusion on the list of creditors does not bind the creditors or the liquidator to the amount shown
- (12) No material transaction have taken place between the signing of the statement of affairs and the meeting of creditors
